


#### The CCBE is

## **Brief history**

- Created in 1960 to monitor the EEC developments with an impact on the profession
  - ➤ Lawyers Services Directive 1977
  - ➤ Diplomas Directive 1984
  - > Establishment Directive 1998
- Identity card 1977
- Contribution to ECJ case-law (AM&S 1979)



# Brief history (contd)

- Code of Conduct 1988 + Charter of Fundamental Principles 2006
- Today, the recognised representative of the profession with the EU institutions
- Permanent Delegation to the EU Courts and to the EFTA Court
- Also liaises with lawyers organisations outside Europe

- Monitor the impact on the profession of European legislation
- Ensure that rule of law and the fundamental values defended by the profession are respected
- Contribute to the good quality of legislation
