ACTIVITES OF THE LEGAL EDUCATION COMMISSION

During its last meeting in Luxembourg, the Legal Education Commission had decided to develop two projects:

- A second edition of the International Contract Competition in Warsaw
- The organization of a seminar on Brexit in Madrid

• Regarding the International Contract competition in Warsaw:

The competition is taking place from the 12th to the 14th of May.

8 teams from 7 different Bars are participating (Madrid, Devon & Somerset, Cluj, Bucharest, Sofia, Warsaw, and Antwerp), and the team of judges is composed by representative of various Bar Associations from different countries (Poland, Spain, Rumania, and Vice President Michele Lucherini as representative of the FBE).

· Regarding the Seminar on Brexit:

As it was mentioned in the report for the Barcelona Meeting, although dates were set and approved by the FBE Presidency and the Legal Education Center of the Madrid Bar Association had worked on a programme for the seminar, which draft was sent to the members of the Commission, considering the absence of response from the members of the Commission and the fact that none of the Commissions of the FBE has ever organized an event of this type, we considered that it would be better to address the issue of Brexit by means of a newsletter that would be sent to the members of the FBE.

It seemed like a better way to reach more European lawyers since the Bar Associations members of the FBE will pass on the newsletter to their members, and the FBE Presidency approved the Project.

This newsletter will follow the scientific programme that was initially established for the seminar and would be send in 4 or 5 numbers, each one treating a different topic. (see draft

programme for the newsletter).

From the Madrid Bar Association, we have started to contact possible writers. During the last Madrid Meeting, we also organized a panel on the subject "Brexit challenges facing Europe" to which participated Vice President Sara Chandler along with other professionals whom we are

hoping will participate as well in the newsletter.

We are also hoping to receive help from the others members of the Presidency and from the Presidents of Commissions and will be grateful for any recommendations they would have for possible writers to prepare articles on the different themes of the Programme, in order to start

publishing the newsletter as soon as possible.

Reporting period: 11.02.2017 - 01.06.2017

This Periodic Activity Report covers the activities of the Eastern Bars Commission for a period of 4 months, since previous report, from the meeting of Barcelona.

In Barcelona Eastern Bars Commission has set the next meeting for Craiova, Romania during 5^{th} - 6^{th} of May 2017. The meeting was planned to be correlated to the international conference Organized by Dolj Bar Association on the topic of Independence of Lawyers. Due to the participation of many Eastern Europe Bars, non-yet members of FBE, the presidency of FBE has appreciated the great importance of this meeting, in order to promote the FBE to the bars of the Eastern Europe and to help the Federation to retain and increase its influence, by the adhesion of new members.

At Craiova meeting were present Mr. Cristoph Munz, the Treasurer of FBE, and Mr. Charles Kaufhold, the Secretary General of FBE. Mr. Munz has made a general presentation of FBE and Miss Stanca Gidro has presented the activity, role and importance of Eastern Bar Commission and has been the moderator of the round table on the topics of the common challenges of the lawyers of Eastern Bars, as well as the specific national challenges for lawyers from Eastern Europe. As Non-members of FBE, representatives of bar associations from Albania (Tirana), Bulgaria (Vidin), Greece (Thessaloniki), Moldova (Chişinău), Serbia (Zaječar, Niš) and of various Romanian bar associations were present.

The meeting was a success, Serbian Bars and Bulgarian Bars having expressed their interest in FBE activities and taking into consideration the possibility of adhering.

The Legal Innovation International Conference will be held in Wrocław on 21-22 April 2017.

The Conference is organised by the Centre for Research on Legal and Economic Issues of Electronic Communication (CBKE) operating at the Faculty of Law, Administration and Economics of the Wrocław University and the Court of Appeal in Wrocław in cooperation with the European Bars Federation, the Regional Chamber of Legal Advisors in Wrocław, and the Regional Bar Association in Wrocław.

As a collaboration between commissions, I have to mention The Conference about New Technologies – Legal Innovation in Wroclaw, Poland, where were discussed issues related to the use of new technologies that lawyers encounter in their everyday practice, including issues related to personal data, rules for accessing public information, and advanced tools for lawyers. During the Conference, the speakers will also talk about digitisation in courts, as well as digitisation in enforcement, and land and mortgage registration proceedings. As a speaker was Ms. Diana Andrasoni, from Eastern Bars Commission.

The Eastern Bars Commission has supported the second competition on international trade agreements organized by the Fédération des Barreaux d'Europe (F.B.E.) on May 12–14 in the Warsaw Bar Association sending delegate lawyers from the Cluj Bar Association. The originator of the competition and its host was the Warsaw Bar Association (Poland). The attorney-at-Law Calin Viorel luga participated as juror at the contest with the presence of a team of 2 young female attorneys who ranked second of 8 teams. Teams from Poland, Belgium, Bulgaria, Romania, Spain and the UK took part in the competition. This is the second time when the delegates from the Cluj Bar Association win the second place, after Bulgaria team.

Eastern Bar Commission had some results in its objective of increasing cooperation amongst Eastern Bars. New members and observers projects will be developed. Discussions started at Craiova meeting are ongoing. Common projects will be discussed at Hague meeting.

The working program proposed for the next 6 months:

- 1. State interference in freedom and independence of advocacy.
- 2. Legal education in schools
- 3. The principle of equality of arms threatened in ex-communist countries by the magistrate prosecutors statute. Professional relationship between Magistrates (Judges and prosecutors) and attorneys.

DRAFT RESOLUTION

"On the 3rd June 2017, the General Assembly of the FBE, which represents 250 member Bars and their 850.000 member lawyers, expressed its grave concerns for the situation of Judges and Lawyers in Poland, recognizing that there has been an erosion of the independence of Judges, prosecutors, lawyers and the administration of justice because of the intervention of the government in the appointment and dismissal of Judges, failure to respect the decisions of the Courts and interference in the prosecution service."
