

## **FBE HUMAN RIGHTS & FREEDOM COMMISSION**

### **INTERIM REPORT ON THE REFUGEE CRISIS IN EUROPE AND THE ROLE OF EUROPEAN BAR ASSOCIATIONS.**

In response to the survey of the Human Rights & Freedom Commission about the response of the legal profession in Europe the Commission presents this interim report to the FBE General Assembly in Strasbourg 14 My 2016.

#### **Conflict in the 21<sup>st</sup> Century and displacement of people**

Throughout the first 15 years of the 21<sup>st</sup> century there have been movements of refugees displaced from areas of acute conflict, in Africa, the Middle East and Aghanistan. This has been seen clearly in the dangerous crossings of the Mediterranean and the long marches of refugees across European states. Concern for the human rights of refugees in these situations has been at the centre of the FBE's human rights' policy.

#### **Response of the Legal Profession in Europe**

Refugees' rights include access to legal advice and assistance. This depends on access to lawyers who are competent and available to assist. The response of the legal profession is varied, in some countries legal aid and assistance is paid for by the state, in others efforts are pro bono and provided by volunteers. Jonathan Goldsmith<sup>8</sup> writes of his knowledge of CCBE member bars which have responded to the call to assist refugees. In Sweden, the bar runs a pro bono project, where members volunteer to assist new arrivals with free legal advice. Teams operate at the country's two major railway stations, Stockholm and Malmo, for at least two hours a day. Many who arrive are reluctant to seek asylum in Sweden and continue their journey to, say, Finland, without having had the opportunity to receive proper advice. The pro bono teams work next to a sign, and wear vests, advertising in English, Arabic and Dari that advice is on offer.

The Spanish bar has set up a register of more than 1,500 lawyers ready to advise those coming to the country on the implementation of the EU's relocation scheme. The bar is also ready to send people to immigration 'hot spots', under an EU-wide scheme that many hope will eventually be established. However, there is no information from the Spanish government as to access to refugees in order to offer free legal advice.

Legal advice is offered in other countries. The Frankfurt, Wuppertal, Nuremburg and Berlin bar associations provide free legal advice to new arrivals. The Berlin Bar has a project to assist refugee children. There are more than 3000 unaccompanied minors and over 500 lawyers have signed up to assist them with legal advice and assistance. There are approximately 80,000 refugees in Berlin. The German Federal National Bar<sup>1</sup> has established a new specialist title for Refugee Advice, so that German lawyers know where to refer people for legal assistance. The German Government estimates that there are up to 1.5 million people seeking to stay in Germany.

The project Safe Passage is based in London and Calais. Working with French lawyers in Calais, the UK based Migrants' Law Project assists vulnerable people in the refugee camps, mostly unaccompanied minor, children and other groups, and reunite them with family in the UK. Once a "take charge request" under Dublin III is accepted by the UK Home Office project workers organise the client's journey from Calais to London, and then they receive welfare support from UK non-governmental organisation (NGO) Refugee Action and a UK lawyer to take on their asylum claims in the UK.

In Italy, the national bar ran the 'Lampedusa project' for six months in response to increased arrivals. More than 100 lawyers joined and the national bar provided training so they could advise on Italian, European and international law. On 10 December 2015 the Florence Bar Association provided training for lawyers in human rights law, and information about rights of unaccompanied minors, and have several lawyers who provide pro bono legal assistance. ASGI, an Italian association, mainly of lawyers, deals with the defence of foreigners and their rights in Italy.

The Turkish National Union of Bars has set up a project in the southern provinces of Turkey to investigate needs in order to improve legal aid for the Syrian population in the south. It is made up of local lawyers and NGO's and has a consultation mechanism with the Syrian refugees. The report of this consultation and investigation will be published shortly.

The Budapest bar runs a dedicated page on its website with a database of those lawyers willing to provide pro bono legal assistance to migrants subject to criminal or other administrative proceedings in the country. In the local Bulgarian bars near the border with Turkey, almost all lawyers are involved in the representation of migrants.

In Poland there are projects to assist. The Opole legal advisors have applied for funding from the Polish National Legal Advisors Association to assist people who attend the Centres for Foreigners. The Opole Bar have met with the Office for Foreigners to discuss their proposal. The project proposal includes training for every legal advisor in asylum law, regular attendance at the Centre for Foreigners in Opole, meetings with experts in psychology and cultural sensitivity, and English language classes. They also propose to send advisors to Greece.

The National Association of Romanian Bars has founded the National Institute for the training and improvements of lawyers in Romania, who is in charge for organizing the continuous training of the attorneys. For the Regional Centre Cluj. Due to the fact that asylum and migration legislation is not very well known, the National Institute has elaborated written material in English. The Institute will hold courses for attorneys on this subject, starting in May 2016.

The American Bar Association's Rule of Law Initiative (ABA ROLI) runs a programme in Turkey to assist Syrian refugees. Supported by the US Department of State's Bureau of Population, Refugees and Migration, ABA ROLI has trained over 50 local lawyers this year to assist Syrian refugees to exercise their rights under the Turkish legal system. They have developed an SMS-based legal helpline platform, which they would like to extend to other countries, in particular to refugees who take the western Balkans route from Turkey into the EU.

Following the proposal of the Deutschen Anwaltvereins (DAV), the CCBE has launched a refugee advice project to raise sufficient funds to provide for volunteer lawyers from European jurisdictions to assist in Greece with expert legal advice on immigration and asylum law.

The FBE has agreed to contribute 10,000 Euros to the CCBE project and recruit volunteers to go to Greece for a period of 2 to 3 weeks. In a complimentary initiative the FBE, together with the Madrid Bar Association, is planning a small investigative delegation to carry out a needs assessment in Idomeni or Lesbos in order to plan what assistance can be offered.

### **Conclusion**

We are facing one of the greatest human rights challenges of the 21<sup>st</sup> Century. It is the duty of the international legal community to protect human rights, access to justice and respect for the rule of law. The number of states which believe that international law can be ignored is growing. In each of our own jurisdictions we must be the guardians of the values of humanity and ensure that we are able to overcome the refugee crisis by showing that we can assist people wherever they need to assert their human rights.

With the support of the Euro-Mediterranean Foundation of Support to Human Rights Defenders (EMHRF), the British Embassy in Morocco and the Arab Human Rights Fund (AHRF), the Association Droit et Justice launched in August 2013 a program of legal aid for asylum seekers in Morocco. Migrants in Morocco mainly come from sub-Saharan Africa. Some of them have had to flee their country after being persecuted because of their race, religion, nationality, political opinion or because they are members of a particular social group. They are therefore eligible for asylum but do not have access to information on procedures for granting refugee status in Morocco. Those who apply for asylum are not assisted by a lawyer. The goal of this project is to train a team of lawyers and jurists willing to invest voluntarily in legal aid for asylum seekers by being assigned one case per year under the supervision of Droit et Justice. In this way, lawyers will use the acquired theoretical skills to assist migrants in their application for asylum in Morocco. Of course, our association provides permanent legal support, as well as ongoing training, to the volunteer lawyers and

jurists. The issue has gained so much importance recently that the Moroccan authorities have decided to establish a national refugee status determination system. Until recently, the United Nations High Commissioner for Refugees has been the decision-making body in this area.

They work in partnership with other community organisations including partners from Europe (when running transnational projects).
