The President of the Commission has also sent a very complete activity report informing that the commission held two meetings in July and September and that a new vice-president has been appointed.

The projects of the Commission are as following :

Carrying out joint activities of several bars on various topics of interest, both professional and art, culinary, sports, tourism, etc., with the aim of mutual knowledge of the specifics of each country.

A. The aim of the TASTE OF LAW program is to promote professional cooperation between law firms and lawyers through art and cuisine, two universal ways of getting to know each other and getting to know each other better.

The first edition of the program will be held in Cluj-Napoca on May 16-18, 2024 with the participation of Westminster & Holborn Law Society.

Each bar association wishing to participate in the program will be able to send a maximum of 10 lawyers.

The intention to participate in the program should be sent to the email address ofBarActionCooperationCommissionFBE commission coordination des actions des barreaux@baroul-cluj.rono later than February 28, 2024.

The following should be mentioned:

- The agreement to organize one of the following editions of the program in the future

- The number of participating lawyers and areas of law concerned

- Whether any of the participating lawyers are artists who wish to exhibit their work and what it consists of (painting, sculpture, books, music, etc.).

The final structure of the program for May 16-18, 2024 and the invitation to participate in the program will be communicated to each FBE member bar

The program will take place over a period of three days and is divided into three main parts:

1. Day one: The scientific part (a common theme between the legal profession and culture, as well as topics specific to the field of law in the area of interest of each participant)

2. Day two: The practical part (participation in interactive activities with artists and getting to know the Romanian cuisine, including art exhibitions by artist lawyers)

3. Day three: The social part (it will be organized every evening, and the last day will be dedicated to tourist attractions of your choice).

B. We would like to support our fellow lawyer, Associate Professor Radu Chiriță PhD in developing a study on how the European Court of Human Rights has evolved / declined over the years, a study that seeks to identify the causes of any decline in the activity of this court.

The help consists in disseminating a questionnaire to answer (anonymously) the questions necessary for the study. The questionnaire will be sent to each Bar Association with a request to forward it to the lawyers of the Bar Association.

We ask our colleagues in the Federation to help us disseminate the questionnaire to colleagues across Europe, especially those in Eastern Europe, countries that have made more use of the ECHR due to social and historical developments.

Stanca Gidro has sent the draft survey called "ECHR – myth or reality" to the Presidency, asking to send it to our member Bars.

After Presidency's approval, Marta will send it to our members and a link to the survey will be published on our website.

C. Having regard to the press release of the Romanian National Union of Bar Association of September 4, 2023, entitled:

"A day without lawyers – a day in which the rule of law does not exist! Awareness campaign on the role and importance of the Lawyer in defending citizens' rights and freedoms"

as a result of the recurring problems raised by the 42 bars in Romania, regarding the frequent dysfunctions encountered by lawyers in the exercise of their judicial activities and the tendency to tighten the taxation of the liberal professions:

We call on the General Assembly to adopt the following resolution:

Resolution in support of Romanian lawyers on the role and importance of the Lawyer in defending the rights and freedoms of citizens in Romania

The General Assembly of the European Bar Federation, representing 210 member bars and one million lawyers,

taking cognizance of the approach of the Romanian National Union of Bar Association of September 4, 2023, entitled: "A day without lawyers – a day in which the rule of law does not exist! Awareness campaign on the role and importance of the Lawyer in defending citizens' rights and freedoms"

with the aim of eliminating the frequent dysfunctions encountered by lawyers in the exercise of their judicial activities and to reject the draft law aimed at tightening the taxation of the liberal professions,

having regard to the obligation of all EU Member States to promote and ensure the role of the lawyers in the judicial system as an element of free access to justice for citizens,

expresses its concern about the rights of lawyers in Romania and their economic situation and calls on the Romanian Government and the Romanian judicial bodies to grant lawyers the role and importance they should enjoy in any State governed by the rule of law, their activity being an activity of public interest.

The FBE intends to support the Campaign initiated by U.N.B.R. for the maintenance of high standards in the legal profession in Romania.
