Maria Dymitruk, PhD "Demands of judicial impartiality in the age of generative AI"

Dr. Maria Dymitruk – President of the FBE New Technologies Commission, academic researcher at the Faculty of Law, Administration and Economics of the University of Wrocław. Author of a doctoral thesis on the admissibility of the use of AI in civil proceedings. She is also an attorney-at-law specialising in the field of IT/AI. She has an extensive portfolio of scientific and professional publications in the field of LegalTech, as well as broad research experience.

Manuel Martinez Ribas "A critical perspective from what we already see in our law firm practice and enacted legislation in Spain"

Manuel Martinez Ribas – Member of the Barcelona Bar Association and member of the Information and Technologies Communication Section. He specialises in intellectual property (IP) and information and communication technologies (ICT). From 1996 to 2001 he served as a researcher at IESE (University of Navarra) and held a leadership position at The Information Highway Group, overseeing various European R&D projects in ICT. Prof. Dr. Jordi Nieva-Fenoll "Generative AI and ADR"

Prof. Dr. Jordi Nieva-Fenoll – Full Professor (Chair) of Procedural Law at the University of Barcelona. He is author of 11 monographs and over 100 papers concerning Law of Evidence; Res Iudicata; Cassation; Artificial Intelligence, Neuroscience and Procedure among other topics. He holds 5 Doctorates honoris causa in Universities from Latin America and has been panelist in over 200 international congresses in 20 countries.

Egidia Cirillo "The role of Generative Artificial Intelligence in legal conflict resolution"

Egidia Cirillo – a computer engineer specialized in Artificial Intelligence, holding a master's degree from the University of Naples Federico II. Currently, she is engaged in academic research at the same institution, focusing primarily on Computer Vision and Generative Artificial Intelligence. As a doctoral candidate in the field of Artificial Intelligence, she is actively contributing to the development and advancement of innovative technologies in the sector. Among the most relevant projects are works on image and video detection using deep learning models. She actively contributes to projects based on generative AI and the use of Large Language Models (LLM).

Daša Tičar, LL.M. "Collection of (sensitive) personal data when developing AI driven tools: a CREA-II perspective"

Daša Tičar, LL.M. – works as researcher at the Department of Legal and Economic Sciences, Faculty of Law, University of Ljubljana.
